### *Who Do We Serve?*

**THE PERCEPTION:** Most of the 35,000 people we see each year are on welfare.

**THE REALITY:** Most are working, retired or disabled people with an average income below \$15,000. Only 3% – 4% are on welfare.

### *What Keeps Them From Moving Forward?*

It's a lack of financial resources combined with factors beyond their control like earnings that can't keep pace with the cost of living and rising health care costs. It is also a lack of role models and a clear plan for success.

### *We Create Innovative Solutions*

**Arthur & Friends:** Hydroponics greenhouses that offer job training and income generation. Arthur & Friends has garnered national attention from the NY Times to the White House.

**Pathways to Prosperity:** A teaching model that is moving families out of generational poverty. **The first 16 graduates increased their income by \$216,000 in year one.**

### *Investment Outcomes*

Every NORWESCAP program is tracked for changes in conditions and behaviors of our customers; making sure our investors get a return on their contributions.

- Over \$8 million of assets purchased through Individual Development Accounts
- \$4.9 million saved by local food pantries through our Food Bank
- 82,000 hours for local nonprofits from our volunteer resource center
- 1,800 families are able to work each year because of our child care services
- 90 women back in the workforce annually through our Career Transitions Project
